Please read the below guidelines to determine if a store requires this form for 2014. Stores that submitted this form in April of 2013 may not need to submit this form for the December 2013 submission. Submit this form only for :

- NEW Hobby Only or NEW HTA Stores that did not have this form submitted in April 2013.
- Submit this form to establish any new Distributor of Record agreements for 2014 (any DOR agreements submitted and approved in April of 2013 will remain intact for 2014 unless a new DOR agreement is submitted).
- Topps Direct Stores that are transitioning to the distributor network only need this form if one was not submitted in April 2013.

Form must be signed by Hobby Store Owner and Distributor Owner. Only Topps Authorized Distributors may submit this form on behalf of Hobby Stores. Please type information directly into form in cells provided.
